WHEREAS, the Wheatfield Town Code contains and specifies the local laws, and ordinances of the Town of Wheatfield, and it has been determined that the Town Code is outdated and does not properly address issues concerning Subdivision Signage; and

WHEREAS, the Town has prepared draft language to revise the Town Code, Chapter 169, Subdivision of Land; and

WHEREAS, in accordance with Part 617 of the implementing regulations pertaining to Article 8 (State Environmental Quality Review Act – SEQRA) of the Environmental Conservation Law, the Wheatfield Town Board has conducted an environmental review of this revised Code, and **WHEREAS**, the Town has identified that there are no other Permitting or Approval agencies for this action, and

WHEREAS, a public hearing was held regarding these Code amendments on 2/26/18 and comments were received, and

WHEREAS, pursuant to Municipal Home Rule Law, the Town Board is proposing to adopt this Zoning Code amendment by enacting a Local Law.

NOW, THEREFORE BE IT RESOLVED, the Wheatfield Town Board, in accordance with the State Environmental Quality Review Act (SEQRA) has determined that the proposed amendment of the Town Code, Chapter 169 Subdivision of Land, will not adversely affect the natural resources of the State and/or the health, safety and welfare of the public and is consistent with social and economic considerations and therefore issues the attached SEQR Negative Declaration in accordance with Section 617.7 of the SEQR regulations, and

BE IT FURTHER RESOLVED THAT, the Supervisor is authorized to sign the Environmental Assessment Form (EAF), which will act as the Negative Declaration.

WHEREAS, the Wheatfield Town Code contains and specifies the local laws, and ordinances of the Town of Wheatfield, and it has been determined that the Town Code is outdated and does not properly address issues concerning Subdivision signage; and

WHEREAS, the Town has prepared draft language to revise the existing sections of the Subdivision of Land Chapter of the Wheatfield Town Code; and

WHEREAS, the Town Board held the required public hearing on 2/26/18 and received public comment; and

WHEREAS, pursuant to Municipal Home Rule Law, the Town Board is proposing to enact a local law, as follows:

Be it enacted by the Town Board of the Town of Wheatfield, New York, that the Wheatfield Town Board amends the Wheatfield Town Code as follows:

- 1. Subdivision of Land Chapter 169
 - Article IV Design Standards
 - Amend Section 169-19 Street Design, by adding a new paragraph Q. as follows:
 - Q. Signage. The type (size, shape, style) of street name sign shall be in accordance with Town standards. All new streets shall also require the appropriate traffic control signage in accordance with the National Manual of Uniform Traffic Control Devices (MUTCD current edition) including the New York State Supplement (current edition) and/or as requested by the Town. All signage types and locations must be shown on the construction drawings. For existing approved subdivision phases, signage types and locations shall be determined by the Town Highway Superintendent and Town Engineer during the PIP process. Street name signage and traffic control signage will be provided by and installed by the Town of Wheatfield at the cost of the developer/applicant. These costs shall be based on an approved sign fee schedule and the total cost to the developer/applicant will be finalized by the Town during the PIP process. These costs must be paid to the Town prior to sign installation and installation must be complete prior to final acceptance of the PIP.
 - Article V. Documents Submitted

- Amend Section 169-29 *Major subdivision final plat and accompanying data*, by amending Section 169-29(B)(14) as follows:
- (14) Construction drawings, including plans, profiles and typical cross sections, as required, showing the proposed location, size and type of streets, sidewalks, streetlighting standards, **street signs, traffic control signs,** street trees, curbs, water mains, sanitary sewers and storm drains, pavements and subbase, manholes, catch basins and other facilities. The construction drawings shall also include elevation contours for surrounding properties for a distance satisfactory to the Town Engineer with intervals of one foot or less

WHEREAS, the Town Board has issued a Negative Declaration in accordance with SEQR requirements.

NOW THEREFORE BE IT RESOLVED, that the Wheatfield Town Board amends the Code of the Town of Wheatfield Chapter 169 entitled "Subdivision of Land" to provide for the revision of the Town Code as referenced above.

- 3. All requirements of the New York State SPDES General Permit for Stormwater Discharges from Construction Activities (GP-0-15-002) must be complied with for this project.
- 4. Access to the site from Shawnee Road will be limited to Knottingwood Drive only. A Road Bond for \$100,000.00 must be provided to cover potential damage to the road during construction and the bond must specifically reference Knottingwood Drive.
- 5. All required Town fees (connection fees and phase fees) must be paid prior to construction commencement.

Specification Sections 02200-Earthwork, 02510-Asphalt Concrete Paving, 02520-Portland Cement Concrete Gutter and Curbs, and 02700-Site Drainage have been revised along with Standard Details RD-1, RD-2, ST-1, ST-2, ST-3, ST-4,ST-6,and ST7.
