Additionally, in order for the Recreation Department to permit said fitness classes to occur, Be Moved Fitness LLC must provide a current General Liability Insurance policy to the Town naming the Town as an additional insured for these fitness classes to occur can be revoked at any time should any park rules fail to be followed, or Be Moved Fitness LLC does not provide a current insurance policy for the activities that names the Town as an additional insured.
