WHEREAS, the Federal Government and New York State has made numerous announcements and directives regarding the continuing response to the Corona Virus (COVID-19), and

WHEREAS, the Town of Wheatfield must take into account these recent developments and those that occurred over the past few days regarding the Corona Virus (COVID-19), together with the State of Emergency that was declared in Niagara County, and

WHEREAS, Town Supervisor Don MacSwan, issued as State of Emergency Declaration for the Town of Wheatfield effective March 16, 2020, and the Town Board of Wheatfield by resolution on March 19, 2020 approved and supported said State of Emergency Declaration, and

WHEREAS, to authorize Wheatfield Town Supervisor, Don MacSwan, to be delegated the authority to cancel a scheduled Town Board Meeting and to schedule and cancel Special Town Board meetings pursuant to Town Law Section 62, due to the Corona Virus Emergency, a Town Board resolution is required;

NOW, THEREFORE, BE IT RESOLVED,

THAT, pursuant to Section 62 of the New York State Town Law, Wheatfield Town Supervisor, Don MacSwan, is hereby delegated the authority to cancel a scheduled Town Board Meeting and to schedule and cancel Special Town Board meetings, and said delegation of authority is due to the flexibility of meeting scheduling necessary during the current Corona Virus Emergency, and

THAT, this delegation of authority has been granted due to Corona Virus – COVID-19. This situation threatens the public health and safety, and

THAT, this delegation of authority requires that the Town Board will be informally polled prior to any meeting change and that any such meeting change will be publicized on the Town website and published whenever reasonably possible, and

THAT, this delegation of authority will only last during the Corona Virus emergency situation.

To approve a Town of Wheatfield Resolution for the Wheatfield Veterans Memorial as it Relates to the Town of Wheatfield's Master Plan

WHEREAS, the Town of Wheatfield seeks to expand its availability of accessible cultural, heritage, and educational sites with opportunities to engage, educate, increase awareness and provide an outdoor area to honor all branches of the US military and host remembrances for the fallen heroes of the United States.

WHEREAS, the existing areas in Wheatfield dedicated to Veterans' memorial activities existing recreational facilities suffer from a lack of parking and non-compliance with ADA regulations;

WHEREAS, the Town of Wheatfield Comprehensive Plan has not been updated since 2012;

WHEREAS, it has been determined by the Wheatfield Veterans Memorial Inc. committee that the best location for construction of a permanent Veterans Memorial in Wheatfield is contiguous to the Wheatfield Town Hall for permanent preservation to remain in the public domain in perpetuity;

NOW, THEREFORE, BE IT RESOLVED,

THAT, in lieu of a Parks and Recreation Master Plan, this resolution serves to affirm that this project is consistent with the Town of Wheatfield's Comprehensive Plan.

To approve a Town of Wheatfield Resolution in Support of the Wheatfield Veterans Memorial Inc. Grant Application to the Niagara River Greenway Commission.

WHEREAS, the Town of Wheatfield owns land on and surrounding the Town Hall, located at 2800 Church Road in the Town of Wheatfield;

WHEREAS, the Wheatfield Veterans Memorial Inc. seeks to construct Veterans Memorial, a public heritage, cultural and educational area on nearly 15,000 square feet of land owned and maintained by the Town of Wheatfield behind the town hall;

WHEREAS, the development of a permanent and centrally located Veterans Memorial in Wheatfield to honor all four branches of the United States military will provide important cultural, heritage and educational purposes;

WHEREAS, the Town of Wheatfield will provide the project oversight and maintenance following the completion of the project in perpetuity;

NOW, THEREFORE, BE IT RESOLVED,

THAT, the Town of Wheatfield Town Board supports the development of the Wheatfield Veterans Memorial and the efforts of the committee to seek grant funding from the Niagara River Greenway Commission; and,

NOW, BE IT FURTHER RESOLVED,

THAT, Connie D. Miner & Co. Grants Consultants be authorized and directed to complete the necessary application, forms, and attachments to be submitted through the Niagara River Greenway Commission Funding Application for the purpose of securing this grant.
